# 2019 Can-Yak Fishing Tournament Wavier

## PARTICIPANT AGREEMENT, RELEASE, AND ACKNOWLEDGEMENT OF RISK

### MUST BE COMPLETED AND SIGNED

In consideration of the services of the Mercer Area Chamber of Commerce Inc. and all of the Can-Yak sponsors, their agents, owners, officers, volunteers, participants, employees and all other persons or entities acting in capacity on their behalf, I hereby agree to release and discharge Mercer Area Chamber of Commerce Inc. and all of the Can-Yak sponsors, on behalf of myself, my children, my parents, my heirs, assigns, personal representative and estate as follows:

I acknowledge that certain known and unanticipated risks which could result in physical or emotional injury, paralysis, death or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity. **The risks include among other things:** Collision with other boaters or objects in the water, or other fixed objects: falling out of boat: my own equipment failure or the failure of other's equipment: my own or other's negligence: objects or conditions that may cause injury. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless the Mercer Area Chamber of Commerce Inc. the Great Northern Motel, all of the Can-Yak sponsors from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of Mercer Area Chamber of Commerce Inc. the Great Northern Motel, all of the Can-Yak sponsors equipment or facilities, **including such claims which allege negligent acts or omissions of.**
